I refer to your request for comments from the Department of Agriculture, Food and the Marine, (DAFM), relating to the abovementioned foreshore licence application.

The information on the DECLG website includes

- An Bord Pleanala, (ABP), Inspector's Report
- ABP Decision and
- Foreshore application form and associated drawings.

A copy of the supporting EIS was not available, although a summary of the EIS was included in the ABP Inspector's Report. The available documentation was examined giving rise to the following comments;

Background

This application is for the construction of a new outfall for the Carrigtwohill Waste Water Treatment Plant. The outfall is located in an area known as Slatty Water at the north-eastern side of Lough Mahon, Cork Harbour. Dissipation of effluent from the discharge pipe and diffusers will be via tidal exchange which will disperse the effluent discharge in a westerly direction into Lough Mahon, Cork Harbour.

<u>Aquaculture</u>

There is no aquaculture activity adjacent to the proposed works. The nearest licensed aquaculture activity is to the east of the proposed development at Rossmore Bay, located east of Fota Island, which is separated from the proposed development by Fota Island and an access road. The works will have no significant impact on aquaculture and an improvement in water quality will be beneficial to any future aquaculture activity.

This Department is satisfied that given the location, nature and scale of the proposed activity this development will have no significant impact on aquaculture or fishery harbour related activities and has no objection to a permit being issued.
