CONSTRUCTION OF AN OUTFALL FOR THE DISCHARGE OF TREATED EFFLUENT FROM THE PROPOSED NEW CARRIGTOHILL WWTP, CO. CORK

Dear Mr O'Neill

We refer to your letter of 11th February 2014 regarding the observations received from your Water Services Advisor.

With regard to the conditions outlined in the letter.

- Loose rock armour will be used in place of the Reno Mattress at the diffuser.
- The outfall pipe shall be buried a minimum of 0.5m below the existing bed over its entire length.
- 3. The diffuser shall be constructed to avoid known navigation channels and shall have a marker beacon.
- Four certified hard copies of the drawing titled "Foreshore Licence Map Sheet 1 of 2, Drawing No. 06 Rev A", dated 05/12/2013 are attached.
- 5. All works shall be carried out in accordance with Drawing titled "Foreshore Licence Map Sheet 2 of 2, Drawing No. 07 Rev:, dated 05/12/2013 and Drawing Titled "Outfall and Diffuser, Drawing No. 13524-C-008 Rev B, dated 27/09/2013.
