## ***Terms and Conditions of Use of the Department of Agriculture, Food and Marine's Single Sign on System***

1. The Minister for Agriculture, Food and the Marine grants access to Entitlements Transfer Facilitators - Auctioneer to the Department's Single Sign On System solely for the purposes of submitting Transfer of Entitlement applications on behalf of clients of the Entitlements Transfer Facilitators - Auctioneer.
2. The Minister reserves the right to refuse or withdraw access to the Department's Single Sign On System.
3. In the event that the Minister withdraws access to the Department's Single Sign On System from any Entitlements Transfer Facilitators - Auctioneer that Entitlements Transfer Facilitators - Auctioneer will be notified and may appeal that decision within 14 days to the Minister.
4. The Entitlements Transfer Facilitators - Auctioneer understands that in the event that a client of the Entitlements Transfer Facilitators - Auctioneer instructs the Minister to remove that client from the list of clients associated with Entitlements Transfer Facilitators - Auctioneer, the Minister will remove that client from the list of clients associated with the Entitlements Transfer Facilitators - Auctioneer.
5. The Entitlements Transfer Facilitators - Auctioneer understands that the data collected in this form is collected and held in accordance with all current Data Protection legislation and regulations. ## ***Data Protection***

### **1. Legal basis and purpose of processing**

Transfer of Payment Entitlements is implemented pursuant to EU Regulation 1307/2013. All the personal details collected by the Department are in line with our statutory obligations and in line with the current Data Protection legislation.

### **2. Use of Data Held**

Every customer of the Department has a customer record on the Department's computer database known as the Corporate Customer System (CCS). This is a centralised system which ensures that customer data is kept accurate and up to date. Other systems within the Department may link to this system for the purpose of processing the data in line with scheme/payment obligations. The customer record contains a list of the customer's roles with the Department e.g. herdowner, forestry owner, supplier etc. In addition the record contains personal data including the customer's PPS number, date of birth, name, address, mobile number and e-mail address. We look for your personal data to ensure that we enter the correct contact details on CCS. Your personal data may be shared with other Departments/Agencies for purposes including ID verification or statistical reasons and will be done in line with our Data Protection obligations under Data Protection legislation.

### **3. Period of Data Storage**

The data submitted as part of this application by the data subject under the transfer of entitlements process will be retained by DAFM for a period of time to be determined by DAFM based on business needs and will be destroyed in time but not prior to the coming into effect of the post 2020 Common Agricultural Policy reform measures.

### **4. Further Processing of Personal Data**

DAFM may wish to use data provided by the data subject under this application for statistical or analysis purposes. Data used for such purposes will be pseudonymised (masked) or anonymised as appropriate to protect the security and confidentiality of the data in compliance with the Data Protection legislation in force. Your data will not be transferred outside the EU.

### **5. Requirement for submission of data**

The Transfer of Payment Entitlements is implemented pursuant to EU Regulation 1307/2013. The personal data sought from the data subject is required for the purpose of facilitating an Entitlements Transfer Facilitators - Auctioneer to submit Transfer of Entitlements applications on behalf of clients of the Entitlements Transfer Facilitators - Auctioneer. Failure to provide all the personal data required to register for access to the Single Sign On System will result in DAFM being unable to process the application from the data subject.

### **9. How can I be sure that my personal data is held securely on CCS and that it will be kept confidential?**

The Department is classified as a Data Controller under the Data Protection Acts and must therefore abide by regulatory requirements that set out how it should collect, use and safeguard personal data. Only Department staff requiring access to your record in their normal work can access your personal data on CCS. This form containing your data will be stored securely and then disposed of by confidential shredding.
