DuPuy (Ireland) Ltd has made an application for the retention and use of an existing outfall pipe at their plant at Loughbeg, Rinagskiddy, Co. Cork. The pipe is used for the discharge of surface water runoff from the car park onto the foreshore. As the outfall pipe has already been installed and has been in use since 1998 no "new" works are intended to take place on the foreshore.

On the basis of the above I have no objections to a licence being granted and recommended that the following conditions should be included in any licence that may issue:

- The Licensee shall ensure that there will be no contaminants of any kind discharged to the marine environment and will, in particular, ensure that surface rain water from the surfaced car park shall be routed through a petrol interceptor
- 2(1). Subject to subparagraph (2) the licensee may use an area of foreshore surrounding the said outfall pipe for the purpose of maintaining in continuous working order the said outfall pipe and for no other purpose whatsoever.
- 2(2) The licensee shall minimise disturbance to the said foreshore as much as possible during maintenance and shall reinstate to the satisfaction of the Minister any foreshore disturbed as a result of the said maintenance.
