2. I have achieved certification from an accredited training provider in respect of each of the technology areas for which I am seeking registration (Copy of certification/education details to be supplied to the Department with this application).
3. I accept that installation which I install / commission may, for quality control and financial audit purpose, be inspected by the department and I will assist, by making myself available and / or disclosing any requested information.
4. I accept that failure to act on a direction from the Department or failure to remedy a deficit identified as a result of an inspection, may result in my removal from the DAFM Renewable Installer Register.
5. I accept that my engaging in fraudulent or inappropriate behaviour will result in my removal from the DAFM Renewable Installer Register.
6. I accept that failure by me to comply with these Terms and conditions may result in my removal from the DAFM Renewable Installer Register.
7. I am aware that the Department may de-register installers where the Department has evidence of repeated failures on the part of installers to deliver quality work or give customer satisfaction or where the Department forms the opinion that the installer no longer demonstrates adequate competence's in the specific discipline. I accept that the Department may apply specific conditions to be met by me before I am eligible for re-registration.
8. I agree at my expense to attend targeted workshops or prescribed training or Continual Professional Development when so directed by the Department
9. I undertake that the services provided by me will be in accordance with recognised and accepted practices, acceptable industry standards and any applicable equipment installation guidelines and any relevant national and European laws and guidelines.

I agree to indemnify the Department and keep the Department indemnified from and against any losses, liabilities, demands, damages, costs claims and expenses (including, without limitation, legal costs and expenses) awarded against, suffered, incurred or paid by the Department which arise out of, or are consequential upon or connected with a claim made against the Department by the homeowner relating to the installer's acts or omissions in installing Measures and providing services to that homeowner.
